## SAMPLE LANGUAGE FOR A CHARITABLE BEQUEST TO INLAND NORTHWEST LAND CONSERVANCY

### **Bequests:**

The following four types of bequests direct your gift to Inland Northwest Land Trust, dba Inland Northwest Land Conservancy:

"I give, devise and bequeath to Inland Northwest Land Trust, dba Inland Northwest Land Conservancy, a Washington nonprofit corporation (Tax ID No. 91-1510539), located at 35 West Main Avenue, Suite 210, Spokane, WA 99201

#### **OTHER WAYS TO CONTRIBUTE**

**Retirement Plans:** You may name Inland Northwest Land Conservancy as the beneficiary of your retirement plan. Beneficiary Language: "Inland Northwest Land Trust, dba Inland Northwest Land Conservancy, a Washington nonprofit corporation; Tax ID No. 91-1510539."

**Glfts of Life Insurance:** You may name Inland Northwest Land Conservancy as the beneficiary of your life insurance policy. Beneficiary Language: "Inland Northwest Land Trust, dba Inland Northwest Land Conservancy, a Washington nonprofit corporation; Tax ID No. 91-1510539."
